LIHEAP (Low Income Home Energy Assistance Program) gives low-income households up to \$1,000 to pay for heat. LIHEAP is open to renters and homeowners and DOES NOT have to be repaid.

CRISIS ASSISTANCE helps income-eligible customers without utility service or who have received a shut-off notice. Customers can apply for both Crisis Assistance and LIHEAP at the same time.

CRP (Customer Responsibility Program) can cut your gas bill in half. CRP lets customers pay less each month and past debt is forgiven.

PAYMENT ARRANGEMENTS help customers behind on their PGW bill.

HARDSHIP GRANTS of up to \$1,500 are available for income-eligible customers with a PGW termination notice or those without service. Apply at select Neighborhood Energy Centers ([pgworks.com/nec](#)).

ORDER A FREE METHANE DETECTOR KIT WHILE SUPPLIES LAST



PGW is offering all customers a free methane detector kit, while supplies last. The kit includes information on methane detectors and instructions on where to install them. Detectors provide an audible alarm should gas levels exceed safe limits to alert anyone in the property to call their natural gas utility or call 911 immediately.

As a reminder and whether you have a methane detector kit or not, if you smell gas, leave the area and call PGW's emergency hotline at 215-235-1212.
